Smoke control dampers of type SEDM-2D in the following range of dimensions and following design variants:

SEDM-2D BxH 24C0H, SEDM-2D BxH 24C2H, SEDM-2D BxH 24C4H, SEDM-2D BxH 48C0H. SEDM-2D BxH 48C4H. SEDM-2D BxH 48C4H.

where *B* is the width and *H* is the height from 350x300 to 1105x1105, with hand-operated rearming (...H), where 24... variant is with 24 V DC activation magnet, 48... variant is with 48 V DC activation magnet; the product being without end-switches (..C0.), with one pair of end-switches (..C2.), or with two pairs of end-switches (..C4.); of IP 42 degree of protection of the electric part, and of insulation voltage of 500 V.
